- A. Set Election Date for Alderman Election—**Motion by Aaron Second by Landry to set the election for the Fall of 2018 with the date set for November 6, 2017 and with qualifying dates of July 18-20 and the general election set for December 8, 2018 if necessary. Motion Passed.
- B. Appointment of Interim Alderman to fill the vacancy left by the resignation of Alderman Dave Almond. Interim nominees are Allen Hobgood and Keith Day. Motion to appoint Allen Hobgood as interim Alderman. Motion by Aaron. Second by Corcoran. Roll Call Vote: Voting in favor of the nomination of Allen Hobgood: Roy Corcoran and Liz Aaron. Voting Opposed: Janis Landry and Aimee Bellue. Motion Tied. Motion to appoint Keith Day by Landry. Second by Bellue. Roll Call Vote: Voting in favor of the nomination of Keith Day: Janis Landry and Aimee Bellue. Voting Opposed: Roy Corcoran and Liz Aaron. Motion Tied. Town Attorney Andrew D’Aquila citing R.S. 18:602 asked the Mayor to vote to break the tie. The Mayor Robert Jackson voted to appoint Keith Day as the Interim Alderman to fill the vacancy until an election can be held.**
